The DN/FONSI makes references to the "temporary system of approximately two miles of groomed trails near Wanoga Sno-play" that is open to skiing with dogs. These references would be more accurately stated as the "temporary groomed trail, approximately two miles long, near Wanoga Sno-play".

#### Page 5

The 0.6 mile nordic trail connector between Kapka Butte Sno-park and the Highway 46 underpass will remain open to dogs; however, when this trail connector converges with the main trail, existing orders prohibiting dogs north of Cascade Lakes Highway remain in effect.
